ORDER:

In the reference 1st read above, the Principal Secretary, Information Technology, Electronics & Communication Department has requested to take the necessary steps in execution of PLB HDPE Duct laying of T-Fiber project in the works of all development projects in our state.

2. In the reference 2nd read above, the Principal Secretary to Government, IT,E&C Department, Government of Telangana informed that the materials required for T-Fiber project like PLB HDPE duct and other accessories which are to be laid in the trenches of water pipeline works can be sourced from agencies already shortlisted by RWS&S department through the process of rate contract cum vendor registration agreement and the same agreement holds good for urban sector works also and requested to take necessary steps for laying of PLB HDPE duct for T-Fiber project in the same trenches of water pipeline works by the executing agencies under Mission Bhagiratha (Urban) being implemented by the department.

3. In the reference 3rd read above, the Engineer-in-Chief (PH), Hyderabad has submitted that that all the works/packages of Mission Bhagiratha (Urban) are already let out to the agencies through tender process and pipe laying works are on the verge of commencement. As the work of laying PLB HDPE duct in the pipeline trenches should piggyback with the ongoing work, it is inevitable that the HDPE duct work also need to be entrusted to the same agencies who are already executing the work/package by entering into supplemental agreement for schemes taken up under AMRUT and TMDP.

4. The Engineer-in-Chief (PH), Hyderabad has further submitted that the following agencies are entrusted with Mission Bhagiratha (Urban) works in various towns/cluster of towns against which in column 4 is shown the value of HDPE duct work to be executed in the respective town/cluster of towns.

5. In view of the above, for smooth implementation of laying PLB HDPE duct work for T- Fibre Project, the Engineer-in-Chief(PH) , Hyderabad has proposed as follows:

- I. To accord Administrative Sanction for each of the (13) works as shown against them in Column 4 totaling to Rs.81.00 Crore. The expenditure is to be charged to the funds/budget to be provided by the ITE&C Department.
- II. In respect of works from S.No. 1 to 9, a supplemental agreement need to be entered into with the same executing agencies already in place for PLB HDPE duct work also duly charging the expenditure to the funds/budget provided by the IT,E&C Department.
- III. In respect of works from S. No. 10 to 13, the work of laying PLB HDPE duct need to be entrusted on nomination to the respective executing agencies already in place doing Mission Bhagiratha (Urban) works on Annuity basis as shown in Column 4 above. Separate agreements need to be entered into with the agencies at estimated rates on LS contract mode without linking to the Annuity agreement. Expenditure for the PLB HDPE duct work shall be met from the funds/budget provided by the IT,E&C department.
