Vide reference 1st cited, the Hon'ble High Court have issued orders that "even if there are tangled webs in this case, it is for the respondents to resolve the difficulties, and to finalize the seniority list in the shortest period, Moreover, the time to finalize the seniority list cannot be used as an excuse to make adhoc promotions in favour of others, for such adhoc promotions invariably cause heart-burning and frustration amongst others. Therefore, this Court is of the opinion that, till the seniority list is finalized by the official respondents, they should be injuncted from making adhoc promotions". Accordingly, the provisional seniority list of Chief Engineers have been prepared & communicated to the individuals for obtaining objections in the reference 6th cited.
